QUESTION ONE (30 MARKS)

PLOD CASE

The PLOD is engaged in many countries in Africa undergoing deep mining of precious metals. There is a decentralized engineering function and procurement function located in each country of operation. One of the countries is Rwanda. A need has been identified for the design, preparation of detailed drawings, manufacture, supply, and delivery to site, installation and commissioning of vacuum pilot plant with a capacity of a 500 tons per day. This will be a pilot plant in Rwanda, offering the design potential to increase the capacity to 800 tons per day. A decision has been made to single source this need from a Kenyan company. Negotiations have been underway with the Kenyan company, for in excess of four months so as to agree on the terms and conditions that shall govern the business. Procurement department issued the tender, engaged in its evaluation and with the necessary approach, placed a contract. The agreed completion date is 18 months from the date of the contract.
