- a) Clearly distinguish between the following pair of terms: (10 marks)
- i) Autonomous consumption and marginal propensity to consume
 - ii) Frictional and structural unemployment
 - iii) Devaluation and depreciation of currency
 - iv) Gross national product and Gross domestic product
 - v) Fiscal and monetary policy
- b) Assuming that the central bank implemented a policy that is meant to increase the money supply in the economy. Using an illustration, explain the effect of this policy on interest rate. (10 marks)
- c) The following equations describe a certain economy (10 marks)

$C = 300 + 0.85Y^d \longrightarrow$ Consumption function

$I = 300 - 200r \longrightarrow$ Investment function

$T = 70 + 0.2Y \longrightarrow$ Tax function

$G = 100 \longrightarrow$ Government expenditure

$X = 10 \longrightarrow$ Exports

$M = 150 + 0.06Y \longrightarrow$ Import function

$M^s = 4000 \longrightarrow$ Money supply

$M^D = 0.2Y - 10r \longrightarrow$ Money demand

- b) Using an illustration clearly distinguish between marginal propensity to save and marginal propensity to consume (5 marks)
- c) Explain the factors that determine consumption. (5 marks)

- b) Discuss three adverse effects caused to society by a high rate of unemployment.
